EXPLANATORY NOTE

As a refiled legislative measure from the 18th Congress, this bill seeks to provide for the construction of a national highway from the access road of the Panguil Bay Bridge to the Arsenio A. Quibranza National Highway (Tubod-Ganassi Road) in the Municipalities of Tubod and Baroy, Province of Lanao del Norte.

Opportunities and progress can be gained through better access. One way of reaching progress is for our government to provide better access to all our citizens, particularly, in ensuring unhampered access to our road network. This bill seeks to provide a new road that will give more access to our constituents in the delivery of goods from our farm and forest lands to the major national highways.

The proposed road construction will certainly benefit not only the province of Lanao del Norte but our neighboring provinces as well. This road is envisioned to give a new route for travelers and goods from Misamis Occidental to the Province of Lanao del Norte via the Panguil Bay Bridge and connect to the Tubod-Ganassi road.

Furthermore, the proposed highway will also help in promoting and maintaining peace and order in Mindanao as it will provide more access to our government troops and significantly reduce our response times during disasters.

In view of the foregoing premises, the prompt approval of this measure is earnestly sought and recommended.

AN ACT
PROVIDING FOR THE CONSTRUCTION OF A NATIONAL HIGHWAY IN THE MUNICIPALITIES OF TUBOD AND BAROY, LANA DEL NORTE FROM THE PANGUIL BAY BRIDGE ACCESS ROAD TO THE ARSENIO A. QUIBRANZA NATIONAL HIGHWAY (TUBOD-GANASSI ROAD) AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be constructed, under the supervision of the Department of Public Works and Highways, a national highway in the Municipalities of Tubod and Baroy, Province of Lanao del Norte from the Panguil Bay Bridge to Brgy. Caniogan along the Arsenio A. Quibranza National Highway (Tubod-Ganassi Road). The road shall traverse Barangay Poblacion, Barangay San Antonio, Barangay Patudan in Tubod, Barangay Maliwanag in Baroy, Barangay Pinpin, Barangay Sto. Niño, Barangay Licapao and Barangay Caniogan in Tubod.

SECTION 2. The amount necessary to defray the cost of undertaking and completing the feasibility study and detailed engineering design for this project and other activities related thereto shall be included in the General Appropriations Act (GAA). Thereafter, the Secretary of DPWH shall include in the Department's program the construction of said road, the funding of which shall be included in the GAA.

SECTION 3. This Act shall take effect after fifteen (15) days following its publication in the Official Gazette or in a newspaper of general circulation.
