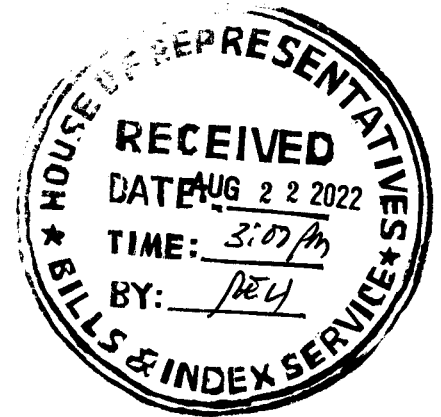

HOUSE BILL NO. 3916

EXPLANATORY NOTE

This bill seeks to establish a regular district office of the Land Transportation Office (LTO) in the Municipality of Gattaran, Province of Cagayan. The establishment of an LTO District Office shall cater the growing needs of vehicle registration, driver's license application and other services provided by the LTO in the First District of Cagayan. The current LTO branch office in the Municipality of Gattaran, Cagayan is a mere annex or extension which services are limited.

The establishment of an LTO regular district office in the Municipality of Gattaran, Cagayan shall be the first and only LTO regular office in the First District of Cagayan comprising the municipalities of Alcala, Aparri, Baggao, Buguey, Camalaniugan, Gattaran, Gonzaga, Lal-lo, Sta. Ana and Sta. Teresita. Hence, the vast legislative boundary requires the establishment of a regular office which shall be a huge help to the residents of the First District of Cagayan.

Thus, the immediate passage of this bill is earnestly sought.

HOUSE BILL NO. 3916

Introduced by Hon. Ramon C. Nolasco, Jr.

AN ACT ESTABLISHING A REGULAR DISTRICT OFFICE OF THE LAND TRANSPORTATION OFFICE (LTO) IN THE MUNICIPALITY OF GATTARAN IN THE FIRST DISTRICT OF CAGAYAN, AND APPROPRIATING FUNDS THEREFOR.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There is hereby established a regular district office of the Land Transportation Office (LTO) which shall be located in the Municipality of Gattaran in the First District of Cagayan comprising the municipalities of Alcala, Aparri, Baggao, Buguey, Camalaniugan, Gattaran, Gonzaga, Lal-lo, Sta. Ana and Sta. Teresita.

SECTION 2. The Secretary of the Department of Transportation shall immediately include in the Department's program the creation and operationalization of the regular district office of the LTO in the Municipality of Gattaran, Cagayan, the funding of which shall be included in the General Appropriations Act.

SECTION 3. The Secretary of Transportation shall issue such rules and regulations as may be necessary to carry out the purpose of this Act.

SECTION 4. – This Act shall take effect after fifteen (15) days after its complete publication in any newspaper of general circulation.
