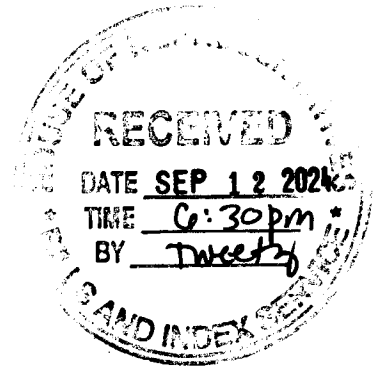

**AN ACT**

**RETURNING THE DEATH PENALTY IN THE REPUBLIC OF THE PHILIPPINES  
FOR THE CRIME OF PLUNDER, RAPE, MURDER, ILLEGAL DRUGS, & OTHER  
HEINOUS CRIMES, THROUGH FIRING SQUAD FOR GOVERNMENT OFFICIALS  
AND THROUGH LETHAL INJECTION FOR OTHER HEINOUS CRIMINALS**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

**SECTION 1. SHORT TITLE.** This Act shall be known as the Death Penalty for Plundering Government Officials & for Heinous Criminals Act of 2025.

**SECTION 2. RETURN OF THE DEATH PENALTY.** Republic Act 9346 or the Act Prohibiting the Imposition of Death Penalty in the Philippines is hereby repealed.

**SECTION 3. DEFINITIONS.** All comprehensive definitions regarding Plunder, Rape, Murder, Illegal Drugs, other heinous crimes in previous laws shall be adopted and its Death Penalty provisions shall be upheld again.

**SECTION 4. IMPLEMENTATION.** Death Penalty shall be through Firing Squad for criminal Government Officials who betrayed the trust of the Filipino People and through Lethal Injection for other Heinous Criminals.

**SECTION 5. IMPLEMENTING RULES & REGULATIONS (IRR).** The Department of Justice (DOJ) shall promulgate the necessary rules and regulations for the successful implementation of this Act.

**SECTION 6. SEPARABILITY CLAUSE.** If for any reason any part or provision of this Act is declared unconstitutional or invalid, the other parts hereof which are not affected shall remain in full force and effect;

**SECTION 7. REPEALING CLAUSE.** All laws, decrees, executive orders, rules or regulations or parts thereof, inconsistent with the provisions of this Act are hereby repealed, amended, or modified accordingly;

**SECTION 8. EFFECTIVITY.** This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in at least two (2) newspapers of general circulation.
