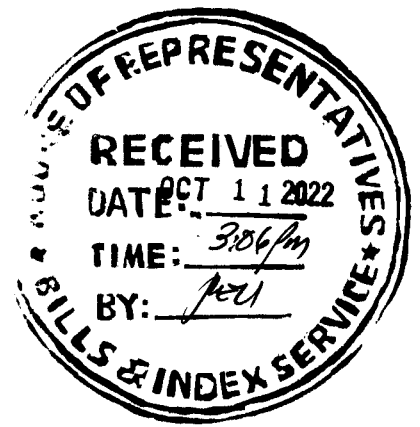

HOUSE RESOLUTION NO. 477



Introduced by Rep. Mohamad Khalid Q. Dimaporo

A RESOLUTION

DIRECTING THE HOUSE COMMITTEE ON MUSLIM AFFAIRS TO USE ITS OVERSIGHT POWERS ON THE IMPLEMENTATION OF REPUBLIC ACT NO. 6734, AS AMENDED BY REPUBLIC ACT NO. 9054 (ARMM LAW) AND REPUBLIC ACT NO. 11054 (BANGSAMORO ORGANIC LAW) TO ASSESS AND COMPARE THE EFFECTIVENESS OF DEVOLUTION ON EDUCATION BY THE NATIONAL GOVERNMENT TO BOTH THE AUTONOMOUS REGION IN MUSLIM MINDANAO AND THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO

WHEREAS, as part of the conclusion on the peace process between the National Government and the Moro National Liberation Front (MNLF), the powers of the National Government on Education have been devolved to the autonomous region in Muslim Mindanao under Article V Section 2(7) of RA 6734, as amended by RA 9054;

WHEREAS, as part of the commitment to the Comprehensive Agreement on the Bangsamoro (CAB) with the Moro Islamic Liberation Front (MILF), the Bangsamoro Organic Law was ratified with devolved powers on Education under Paragraph (v) of Section 2, Article V of Republic Act No. 11054;

WHEREAS, the Bangsamoro Organic Law, and Republic Act No. 9054 or the previous ARMM Law, both state that it should be a top priority of its Autonomous Government to establish, maintain, and support a complete and integrated system of quality education, which shall be a subsystem of the national education system;


WHEREAS, the Committee shall be tasked to conduct an assessment of RA 6734, as amended by RA 9054 and RA 11054 to review the implementation of devolution to the Autonomous Region and its impact on quality education and performance in the region;

WHEREAS, the findings of the said assessment shall provide insights on institutional reform for the Department of Education in regards to decentralization and devolution, and

document the shortcomings of previous administrations in the fulfillment of regional autonomy;

THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to direct the House Committee to use its oversight powers on the implementation of Republic Act No. 6734, as amended by Republic Act No. 9054 (ARMM law) and Republic Act No. 11054 (Bangsamoro Organic Law) to assess and compare the effectiveness of devolution on education by the national government to both the Autonomous Region in Muslim Mindanao and the Bangsamoro Autonomous Region in Muslim Mindanao.
