EXPLANATORY NOTE


Formerly known as Bacoor National High School – Maliksi Annex, the Responsible Village Leaders Learning Academy (RE.VI.L.L.A.) High School was created by the *Sangguniang Panlungsod* through a City Ordinance in 2015. It started its operation with just seven (7) teachers, four (4) non-teaching staff and a population of 371 grade 7 students.

In just six years, the school's population almost tripled its original enrollment size which necessitated the hiring of more teaching and non-teaching personnel and the construction of more classrooms. At present, there is a three-storey multipurpose building with 12 classrooms already being utilized by this school.


Given the population density of the surrounding community and the number of elementary schools that will serve as feeder to this high school, it is highly necessary that the REVILLA High School is established by law.

With full budgetary support from the national government, the State's commitment to deliver unhampered quality basic education is guaranteed. This measure was already approved on Second Reading by the House of Representatives during the Nineteenth Congress.


Immediate passage of this measure is earnestly sought.

AN ACT

ESTABLISHING A HIGH SCHOOL IN BARANGAY MALIKSI I, CITY OF BACOR, PROVINCE OF CAVITE TO BE KNOWN AS THE RESPONSIBLE VILLAGE LEADERS LEARNING ACADEMY (REVILLA) HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There is hereby established, under the supervision of the Department of Education, a high school in Barangay Maliksi I, City of Bacoor, Province of Cavite to be known as the Responsible Village Leaders Learning Academy (REVILLA) High School.

SEC. 2. The Secretary of Education shall immediately include in the Department's program the operationalization of the Responsible Village Leaders Learning Academy (REVILLA) High School, the funding of which shall be included in the annual General Appropriations Act.

SEC. 3. Within ninety (90) days from the approval of this Act, the Secretary of Education shall formulate the rules and regulations implementing the provisions of this Act. Such implementing rules and regulations shall provide for the school's organization, administration, operations and management, in accordance with Republic Act No. 9155, or the "Governance of Basic Education Act of 2001", Republic Act No. 10533, or the "Enhanced Basic Education Act of 2013", and other basic education-related laws.

SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
