#### **EXPLANATORY NOTE**

Section 1, Article XIV of the 1987 Philippine Constitution mandates that "The State shall protect and promote the right of all citizens to quality education at all levels and shall take appropriate steps to make such education accessible to all".

In accordance with this constitutional mandate, this bill seeks to establish a Visayas State University regular campus in the Municipality of Hilongos, Province of Leyte.

Quacquarelli Symonds (QS), a British company specializing in evaluating higher education institutions worldwide, assigned Visayas State University a rating of 3 Stars. VSU was awarded the QS certification on May 8, 2020.

A 3-Star ranking indicates that VSU is "nationally well-known and may have even begun to attract international recognition". This institution conducts credible research, and its graduates are attractive to potential employers."

The Hilongos Regular Campus is intended to serve students who are unable to travel far for college due to family obligations, financial constraints, or other factors, and to provide quality education in response to global needs.

This bill was previously filed in the 19<sup>th</sup> Congress by the undersigned and was approved by the House Committee on Higher and Technical Education on 03-18-24.

In view of the foregoing, the approval of this proposed measure is earnestly sought.

# AN ACT ESTABLISHING A REGULAR CAMPUS OF THE VISAYAS STATE UNIVERSITY IN THE MUNICIPALITY OF HILONGOS, PROVINCE OF LEYTE, AND APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

**SECTION 1.** *Establishment of a Regular Campus.* - There is hereby established a Regular Campus of the Visayas State University (VSU), located in the Municipality of Hilongos, Province of Leyte, to be known as the "Visayas State University – Hilongos Regular Campus".

**SECTION 2**. *Board of Regents*. - The Visayas State University Board of Regents is hereby authorized to find a suitable location in the Municipality of Hilongos for the construction of the VSU-Hilongos Regular Campus and to perform the necessary tasks to acquire said property and construct the satellite campus.

- **SECTION 3**. *Appropriations*. The amount necessary to carry out the provisions of this Act shall be included in the annual General Appropriations Act.
- **SECTION 4.** Separability Clause. If any provision or part hereof is declared unconstitutional, the remainder of this Act or any provision not affected shall remain in full force and effect.
- **SECTION 5.** Repealing Clause. All laws, presidential decrees, executive orders, rules, and regulations or parts thereof inconsistent with the provisions of this Act are hereby repealed, amended, or modified accordingly.
- **SECTION 6.** *Effectivity Clause.* This Act shall take effect fifteen (15) days after its publication in at least two (2) newspapers of general circulation.
