OPENING OF THE FIRST REGULAR SESSION

CALL TO ORDER

At 10:00 a.m., pursuant to Section 18 (a), Rule VI of the House Rules, the Presiding Officer, Secretary General Marilyn B. Barua-Yap, called the session to order.

THE PRESIDING OFFICER (Atty. Barua-Yap). Honorable Members of the House of Representatives, today is the fourth Monday of July, 2013. The Constitution mandates that Congress convene once every year on the fourth Monday of July to commence its regular session.

Pursuant to parliamentary rules and practice, I hereby call the First Regular Session of the Sixteenth Congress to order.

REP. ANGPING. Grant us also that objectivity and sound realism which will guide us on every occasion to a clear perception of that which seems the best. Grant that we may never deviate from that sound impartiality which dictates that we labor without unjust preferences for the good of all. Grant also that we may never fail in loyalty to our people, nor in firm adherence to the principles which we openly profess, nor in the noble resolve to preserve ourselves above all possible corruption and base selfish ambitions.

Help us to be calm in all our deliberations and to be immune from all passion except such as is inspired by the honest quest after truth. May our resolutions be in conformity with Thy precepts even if the service of Thy will should demand sufferings and sacrifices. May we, even in our own little way, endeavor to imitate that rectitude and holiness according to which Thou in Thy providence dost direct and govern everything for Thy greater glory and for the true well-being of human society and of all Thy creatures.

Hear us, O Lord, in order that our minds may never be without Thy light, nor our wills without Thy strength, nor our hearts without the warmth of Thy love, for we ought to have tender lover for our people. Keep far from us every form of human ambition and every kind of lust for illicit gain. Inspire us with a real lively and profound sentiment of what constitutes a sound social order wherein full regard is had for law and justice.

Finally, as a supreme reward, grant us some day to enjoy Thy blessed presence for all eternity, in union with those who have been entrusted to our care.

NOMINATION SPEECH OF REP. SARMIENTO (M.).

REP. SARMIENTO (M.). Honorable Presiding Officer, distinguished colleagues, I am honored to be chosen among my peers in this august Body to nominate a colleague for the Speaker of the House of Representatives.

This is a historic time for our country. Under the bold leadership of President Benigno S. Aquino III, our economy is surging, we are forging peace domestically and strengthening our defenses against external threats. The world has taken notice of a new, more vibrant and confident Philippines.

The Fifteenth Congress can claim significant credit in bringing this about. The country's economic performance since 2010 has been aggressive as evidenced by the numbers shown by major credit ratings in agencies.

The Fifteenth Congress was an active partner of the administration in achieving these milestones and in creating

the policy foundations that now spur the momentum for economic growth.

We need a wise and fair leadership that made the Fifteenth Congress so significant in order to propel this Sixteenth Congress to the same historic heights.

Thus, honorable Presiding Officer, my distinguished colleagues, it is my distinct honor and privilege to nominate Hon. Feliciano "Sonny" Belmonte of the Fourth District of Quezon City as Speaker of the House of Representatives of the Sixteenth Congress.

REP. COJUANGCO (E.). He is a friend, a respected colleague, an experienced and battle-tested leader, and most of all, a unifying force in the House usually divided by opinions.

Mme. Presiding Officer, and Members of this esteemed and respected institution, it is with optimism and faith on the great work we can accomplish together for our beloved country that I second the nomination of Hon. Feliciano "Sonny" Belmonte as Speaker of the House of Representatives of the 16th Congress.

NOMINATION SPEECH OF REP. ANDAYA (R.)

REP. ANDAYA. Mme. Presiding Officer, dear colleagues, ladies and gentlemen.

In nominating the Gentleman from Quezon City, I would rather not dwell on his curriculum vitae.

It is already of public knowledge that he is a turnaround specialist with a knack for rehabilitating firms in dire straits, whether a city government or a heritage hotel, the national airline or the pension fund.

As how he was able to do it, I would not repeat the urban legend about his management style, as rumors that the "S" in "SB" stands for stingy, or strict, or stern are still unconfirmed.

I would rather highlight his recent feat as the architect of the successful makeover of the House, not in appearance but in performance. Performance is better appreciated if presented not with frills but with facts. His scorecard shows that during his watch, 1,033 bills were passed and 447 laws enacted. This means that on the average, one approved bill rolled out of this Hall every 24 hours and one signed law left the President's desk every 48 hours. And many of those were not run-of-the-mill types, but brave, like the RH Law; bold, like the one on sin taxes; and beneficial, like the K to 12 Law.

Yes, not all of us agree with those measures, but we agree on one thing: it takes a leader with guts and grit to push for bills, as well as a fair leader to encourage a free and full debate on those.

My friends, we are all casual employees here, with a probationary term of 1,000 days, subject to renewal by our employers. Some of us may be rehired, some of us might be fired. But it is up to our employers to make that decision. But it is up to us to choose a leader who will bring the best in us in the next 1,000 days and thereby boost our chances of being rehired instead of being retired.

That man is Feliciano Belmonte.

So, let me close my nomination with the profoundest and the most philosophical phrase I can think of—"SB, ikaw na!"

REP. GARIN (S.). Thank you.

Mme. Presiding Officer, distinguished colleagues, maayong aga sa inyong nga tanan.

I rise this morning as Representative of AAMBIS-OWA Party-List to second the nomination of the Hon. Feliciano Belmonte Jr. as Speaker of the House of Representatives.

REP. ALVAREZ (F.). My dear colleagues, Ladies and Gentlemen, the National Unity Party or NUP is proud to nominate the Gentleman from Quezon City as Speaker of the House of Representatives. But there are other two NUPs that are throwing their support for him: one is what I call the Nagkakaisang Unyon ng Palawan as the province's delegation to this Chamber is voting for him; and the other NUP refers to most of the freshmen class of 2013, which a friend wittingly dubbed as "Ngayon lang Umupo sa Parliamento."

NOMINATION SPEECH OF REP. FARIÑAS

REP. FARIÑAS. Mme. Speaker, I rise to second the nomination of the Hon. Feliciano "Sonny" R. Belmonte Jr. as Speaker of the House of Representatives.

Under the leadership of Sonny Belmonte, the Fifteenth Congress was the only Congress that was able to enact for three consecutive years the General Appropriations Act before the start of the Fiscal Year of its effectivity.

NOMINATION SPEECH OF REP. RIDON

REP. RIDON. My distinguished colleagues, elected Representatives of the people, in the past three years, you have seen how the Aquino administration has failed miserably in bringing meaningful change. Despite the touted inclusive growth, the socio-economic divide has never been starker, as the rich get richer while the poor have become poorer than ever.

ACCEPTANCE SPEECH OF SPEAKER BELMONTE

THE SPEAKER. First of all, thank you very much for your confidence in me; it is a real honor. You know the first time I was elected, I could not believe it. The second time, and it was for the full Fifteenth Congress, I could not believe

that I would last that Fifteenth Congress, but here, you have reelected me to the Sixteenth Congress. Kaya salamat sa inyong lahat. (Applause)

Esteemed colleagues, distinguished guests, Ladies and Gentlemen.

It is a rare honor to once more be entrusted with the Speakership of this Chamber. This grave responsibility was first reposed on me briefly in 2001, and again in the Fifteenth Congress.

Today, I am deeply humbled by your vote of confidence. I accept anew this duty equally confident that irrespective of our differing political affiliations, geographic or sectoral interests and persuasion, we will always stand strong and unified in our resolve not merely to consolidate the gains thus far realized, but to move towards our great future. Before you, I pledge to honor your trust with leadership that respects the voice of every Member of this Chamber in all proceedings and uphold the energy of this assembly as a democratic institution of government. At this point, I would like to congratulate the new Minority Leader, Congressman Ronaldo Zamora of the Lone District of San Juan, who happens to be my neighbor actually. The Fourth District of Quezon City adjoins the Lone District of San Juan but that is about all I know about San Juan.

Whether reelected or as new Members of this Chamber, we all witnessed the backbreaking burden legislations this House bore to discard practices of the past and steer the country towards the proverbial "matuwid na daan."

In the past three years, it was this House which overhauled the appropriation process and built the habit of prompt enactment of a transparent and responsive national budget, this House which refused to shirk from the politically difficult task of impeachment and this House which fortified the constitutional promise of accountability in government.

The ratings, our ratings, achieved by this House in successive public trust surveys are not only historic, they are likewise indicative of the transformation of this institution and of our efforts to place our national constituency front, back and center of our legislative agenda.

The remarkable improvements in the country's competitive ratings, governance indicators and corruption indices, the investment-grade credit ratings achieved under President Aquino and the economic growth posted last year and in the first quarter of this year, which are unsurpassed in this region, are extraordinary feats which we achieved even as the world around us grappled with a stale if not contracting international economy and immense political disturbances.

The greatest error we can commit today is to mistake the past deeds of the past three years as ends in themselves and not merely as a preview of greater things to come.

Our task in the next three years must be to resist the costly temptation of resting on our laurels, to inspire greater belief in our collective capacity for greater accomplishment within our country and outside, and to marshal government resources toward making possible a more vibrant and resilient economy and people.

In close collaboration with the Senate and the Executive, we will craft a legislative agenda that will generate greater economic activity in our country, economic activity that benefits the greater number, economic activity that addresses, among others, the problems of poverty, unemployment

and investment. If we stick to that goal, we will never go wrong.

Reducing the impediments to the ease of doing business, reducing red tape, even as we rationalize our incentives framework—meaning to say, there is not one or two businesses that will monopolize the incentives even when they do not need it—and creating a more even and stable regulatory framework (hindi iyong papalit-palit iyong ating policies) that will rid the private sector of its fears to fund our economic expansion especially in such critical areas as power and energy—and I hate to look the Mindanao legislators in the eyes as I say those words, but definitely, we must find ways of solving the power and energy crisis particularly in Mindanao—are essential if we are to sustain our growth and to employ the jobless.

The habit of promptly enacting the national budget must be complemented by judiciousness in the use of public resources. The reprieve enjoyed by our people from additional taxes can be sustained without substantially impairing our future growth with the expansion of efficiency in government spending, and this should be further strengthened and institutionalized in our Appropriations Act and assiduously guarded through the oversight powers of the House. In the past, the oversight power has been just there; this time, let us try to exercise them.

Greater investment in public infrastructure and facilities must be encouraged simultaneously with our concern for prudence in the use of public resources. As we pass laws that deter and close the avenues for corruption, so must we gain greater confidence in using public resources to address and anticipate the needs of our expanding economy, our expanding population as well.

We must nurture a legal ethos that mandates and extols prudence in spending, and transparency and accountability in the use of public funds especially in the use of our Priority Development Assistance Funds or PDAFs. Ambiguity must yield to specific, definite and verifiable development programs and projects for both district and party-list-funded activities.

Indeed, I have asked the party-list groups, and I do challenge them, to get together and come out with a plan on how to spend their PDAF because—what are the rules on this? Let us have them.

A strict obedience to much-tightened guidelines in the use of public resources is the strongest guarantee of efficiency, ensuring that each peso spent generates exponential returns for our people.

For my part, my PDAF, since first serving as a Member of this Chamber in 1992 as a Congressman, were spent strictly within my district in Quezon City, subject always to public scrutiny and sometimes to public criticism.

The Sixteenth Congress concludes with the second half of PNoy's six-year term. These three years are sometimes more difficult to manage because whiffs of the next election hang in the air. This time might not be too different.

Nevertheless, I call upon all of you, my colleagues, to unite behind the administration and our reform agenda in the interest of our people so that the Sixteenth Congress, along with President Benigno S. Aquino's term of office, ends not with a strikeout but with a homerun or even a grand slam.

Reforms in governance cannot be dictated. Government leaders must now augment our "Kung walang corrupt, walang

mahirap" battle cry with "Walang kukurap" and marshal great support for the President's agenda toward a clean, honest, efficient and responsive public bureaucracy.

We must complete the modernization of our institutions and the processes they adopt and rid them of wastages which equally rob our people of essential public services.

Until our accomplishments in the transformation of government become convincingly irreversible, we can neither allow our present gains to be disputed midstream nor frustrate anew the expectations of our people.

My colleagues, our beliefs and philosophies will undoubtedly require us to debate and to disagree as we perform the legislative duties we will set up. But our democratic experience in the past Congress, the Congress which courageously tackled some of the most controversial and divisive of measures should remind us that our differences cannot remotely justify the obstruction of urgent and necessary legislation but must in fact be used to enrich and improve them.

With your help, ours will be a proactive Sixteenth Congress, one that refuses to squander the accomplishments of our predecessors but to build on them, even to surpass them, that we may finally bridge the realities of the present and the promises of the future. Ours will be a visionary Congress that will anticipate our needs and steer our economy to a path of sustained but especially equitable and inclusive growth. Together with you, we will be that Congress worthy of the trust reposed upon it by the constituency who elected us, the Filipino people.
