**A RESOLUTION**

**COMMENDING AND CONGRATULATING THE PINOY POP (P-POP) GIRL GROUP, BINI, FOR MAKING HISTORY AS THE FIRST FILIPINO POP GROUP TO PERFORM AT THE COACHELLA VALLEY MUSIC AND ARTS FESTIVAL 2026, AND RECOGNIZING THEIR CONTRIBUTION TO THE GLOBAL PROMOTION OF FILIPINO TALENT AND CULTURE**

1 **WHEREAS**, Section 17, Article II of the 1987 Philippine Constitution declares that the  
2 State shall give priority to arts and culture to foster patriotism and nationalism and  
3 promote total human development;\_

4 **WHEREAS**, Section 14, Article XIV of the 1987 Philippine Constitution mandates the  
5 State to foster the preservation, enrichment, and dynamic evolution of a Filipino  
6 national culture;\_

7 **WHEREAS**, the all-female P-pop group BINI, composed of Ms. Mariah Queen J.  
8 Arceta A.K.A. “Aiah”, Ms. Ma. Nicolette F. Vergara A.K.A. “Colet”, Ms. Mary Loi Yves  
9 K. Ricalde A.K.A. “Maloi”, Ms. Gweneth L. Apuli A.K.A. “Gwen”, Ms. Lindtsey Stacey  
10 Aubrey C. Sevilleja A.K.A. “Stacey”, Ms. Mikhaela Janna J. Lim A.K.A. “Mikha”, Ms.  
11 Jhoanna Christine B. Robles A.K.A. “Jhoanna”, and Ms. Sheena Mae M. Catacutan  
12 A.K.A. “Sheena”, has been dubbed the “Nation’s Girl Group” for their immense  
13 contribution to the Pinoy Pop (“P-pop”) movement, pioneering a modern, globally  
14 competitive brand of Original Pilipino Music (“OPM”);

15 **WHEREAS**, as a subgenre of OPM, P-pop contributes to its broader promotion and  
16 global recognition, thereby strengthening the Philippine cultural presence and  
17 expanding the international reach and influence of Filipino music and creative  
18 industries;

1 **WHEREAS**, the Coachella Valley Music and Arts Festival is an internationally  
2 renowned annual music and arts festival widely regarded as one of the most influential  
3 cultural events in the world, featuring top global artists and attracting hundreds of  
4 thousands of attendees, industry leaders, and international media attention;

5 **WHEREAS**, participation in the Coachella Valley Music and Arts Festival is considered  
6 a major milestone for artists, as it signifies global recognition, cultural influence, and  
7 entry into the international mainstream music industry;

8 **WHEREAS**, on April 10 and 17, 2026, BINI made history as the first-ever Filipino group  
9 to perform at the Coachella Valley Music and Arts Festival held at the Empire Polo  
10 Club in Indio, California;

11 **WHEREAS**, BINI delivered a high-energy 45-minute set at the Mojave stage, debuting  
12 their new single “Blush” from their EP *Signals* and performing chart-topping hits such  
13 as “Pantropiko,” “Karera,” and “Salamin, Salamin,” effectively bringing OPM to a global  
14 audience of thousands in person and millions via livestream;

15 **WHEREAS**, such achievement highlights the rising global presence of Filipino artists  
16 and showcases the richness, creativity, and competitiveness of Filipino talent on the  
17 world stage;

18 **WHEREAS**, the success of BINI at Coachella 2026 serves as a source of immense  
19 national pride, proving that Filipino musicality and artistry can compete and excel at  
20 the highest levels of the international entertainment industry, thus serving as an  
21 inspiration to aspiring artists and creatives across the country;

22 **NOW, THEREFORE, BE IT RESOLVED**, as it is hereby resolved, that the House of  
23 Representatives of the Philippines commends and congratulates the Pinoy Pop (P-  
24 Pop) girl group, BINI, for making history as the first Filipino Pop Group performance at  
25 the Coachella Valley Music and Arts Festival 2026;

26 **RESOLVED FURTHER**, that this resolution recognizes their significant contribution to  
27 global promotion of Filipino talent and culture, consistent with the State’s constitutional  
28 and statutory mandates; and

29 **RESOLVED FINALLY**, that copies of this resolution be furnished to BINI as a token of  
30 recognition from the House of Representatives.
