CALL TO ORDER

At 3:00 p.m., Speaker Ferdinand Martin G. Romualdez called the session to order.

NATIONAL ANTHEM AND INVOCATION

The Members sang the National Anthem and thereafter, Rep. James "Jojo" A. Ang Jr. delivered the invocation.

SUSPENSION OF SESSION

On motion of Majority Leader Manuel Jose "Mannix" M. Dalipe, the Chair declared a recess at 3:04 p.m.

RESUMPTION OF SESSION

The session resumed at 3:05 p.m.

REMARKS OF MAJORITY LEADER DALIPE

Upon resumption of session, Majority Leader Dalipe remarked that Speaker Romualdez (F.M.) will address the Body.

MESSAGE OF SPEAKER ROMUALDEZ (F.M.)

Speaker Romualdez first welcomed the Members back to the remainder of the First Regular Session of the 19th Congress, wishing that they had enough time for rest and respite from their duties. He then relayed to the Body that together with Deputy Speakers Gloria Macapagal-Arroyo and Aurelio "Dong" D. Gonzales Jr. and House Committee on Information and Communications Technology Chairperson Tobias "Toby" M. Tiangco, he accompanied President Ferdinand R. Marcos Jr. to his trip to the United States for meetings with President Joseph R. Biden Jr., Vice President Kamala D. Harris, Defense Secretary Lloyd James Austin III, and high-ranking executives of the Central Intelligence Agency. He described the trip as most productive and successful where, in conjunction with the Executive, the Legislature had helped in furthering and enhancing the relationship between the Philippines and U.S. that were allies not only historically but also during the recent period of uncertainty and post-COVID, and amidst the tensions affecting the Philippine region.

Subsequently, Speaker Romualdez pointed out that the House has four weeks to complete the legislative agenda identified as priority by President Marcos in his first State of the Nation Address and by the Legislative-Executive Development Advisory Council. He said that he will meet with party leaders to ensure that the Body will efficiently use and maximize the remainder of the First Regular Session to achieve its goals of accomplishing the common legislative agenda of both the House of Representatives and the Senate, as well as that of the Executive. He implored Congress to continue its hard work and diligence as he opined that it can do much in furtherance of the people's interest.

ACKNOWLEDGMENT OF GUESTS

Upon request of Rep. Arnan C. Panaligan, the Chair acknowledged the presence in the Session Hall of the guests of Rep. Rodolfo "Ompong" M. Ordanes.

PRIVILEGE HOUR

The day being a Monday, on motion of Representative Panaligan, there being no objection, the Chair declared a Privilege Hour.

Thereafter, the Chair recognized Rep. France L. Castro for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE CASTRO (F.)

Initially expressing concern over the effects of extreme heat being experienced by ordinary Filipinos especially the students and teachers and thus, the proposal of ACT Teachers Party-List and Alliance of Concerned Teachers for the shift to old academic calendar, Representative Castro next delved into the lack or absence of nurses and other health workers in schools and hospitals. As she discussed the plight and needs of this sector, she cited the small percentage of registered nurses and doctors, including midwives and health professionals in both public and private sectors, that could not substantially meet the growing needs of the populace.

She lamented that the shortage of registered nurses was due to their migration to other countries and decried the government's decision of not filling the vacant plantilla positions but resorting to contractualization instead. She then pointed out the problems besetting the nurses like being overworked and underpaid, and experiencing late payment of salaries; and decried the unpaid and delayed salaries and benefits due them under Budget Circular No. 2020-4, as amended by Budget Circular No. 2021-2 that provides the Department of Budget and Management exemptions of coverage under Section 3 of the Philippine Nursing Act.

Thus, in celebration of Health Workers' Day on May 7, on behalf of the nurses and other health workers, she appealed for a ₱50,000 nurse's minimum salary, payment of pandemic benefits, implementation of safe health worker-to-patient ratio, regularization and not contractualization, and increase of five percent in the GDP for health budget, among others.

REFERRAL OF PRIVILEGE SPEECH OF REPRESENTATIVE CASTRO (F.)

On motion of Rep. Munir N. Arbison Jr., there being no objection, the Body approved to refer the privilege speech of Representative Castro to the Committee on Rules for its appropriate action.

At this point, on motion of Representative Arbison, the Chair recognized Rep. Arlene D. Brosas for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS

Representative Brosas spoke about the announcement of Meralco on the imminent increase in electric bill this March due to the scheduled maintenance of the Malampaya facility, and the Energy Regulatory Commission's (ERC) approval of the implementation of collection of their under recoveries from 2020 to 2022 which they plan to collect for 12 months.

Representative Brosas then called for an investigation into the high electricity rates implemented by Meralco; urged for the review of the Electric Power Industry Reform Act (EPIRA) that paved the way for the deregulation and privatization of the electric power industry which only made money for private companies; and asked about the status of the nation's energy sources considering the spate of electricity shortages and blackouts in the country. She further stressed that it is the duty of the government to make sure that prices of basic commodities and utilities are affordable, and to curb the self-interest of private corporations.

REFERRAL OF PRIVILEGE SPEECH OF REPRESENTATIVE BROSAS

Thereupon, on motion of Rep. Mikaela Angela B. Suansing (M.A.), there being no objection, the Body referred the privilege speech of Representative Brosas to the Committee on Rules for its appropriate action.

Thereafter, on another motion of Representative Suansing, the Chair next recognized Rep. Raoul Danniel A. Manuel for his privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE MANUEL

Representative Manuel discussed the mental health issues facing the Filipino youth especially the students belonging to the so-called "Gen Zs" who are acknowledged to be determined to finish their education. He stressed that issues such as increase in tuition and other school fees, mandatory Reserved Officers' Training Corps (ROTC), and the decrease in the quality of and access to education contributed to the mental health crisis being experienced by the students; pointed out that stress, anxiety, and depression are the common conditions of mental health illnesses which are made worse by the low quality and accessibility of government mental health services including the lack of guidance counselors in public schools; and mentioned the high rate of suicide cases of students in the country which the government should address in order to help the students.

As he explained the several factors such as family issues, State-sponsored harassment, vilification, and red-tagging that contributed to the depression of students and their feeling of being unsafe, Representative Manuel stressed that the government should address the mental health issues facing the students by promoting a patriotic, scientific, and accessible education for all.

REFERRAL OF PRIVILEGE SPEECH OF REPRESENTATIVE MANUEL

Thereupon, on successive motions of Rep. Jaime D. Cojuangco, there being no objection, the Body referred the privilege speech of Representative Manuel to the Committee on Rules for its appropriate action; and thereafter, the Chair recognized Rep. Mark O. Cojuangco to avail of the Privilege Hour.

PRIVILEGE SPEECH OF REPRESENTATIVE COJUANGCO (M.)

Representative Cojuangco delved into the plan of the Department of Agriculture (DA) to purchase ₱2.5 billion worth of biofertilizers as he pointed out that fertilizer scams in the past involved this kind of alternative biofertilizers and cautioned the government to be very careful in the said purchase that would not be beneficial to the farmers compared to the use of urea fertilizers.

As he explained the huge price discrepancies and the amount of nitrogen content between the biofertilizers that would be purchased by DA compared to the existing urea fertilizers being used by the farmers, Representative Cojuangco cited the case of Sri Lanka wherein its economy collapsed due to the non-importation of chemical fertilizers. He then called for an investigation into the purchase of biofertilizer by DA considering the past fertilizer scams that happened in the country.

REFERRAL OF PRIVILEGE SPEECH OF REPRESENTATIVE COJUANGCO (M.)

Thereupon, on motion of Rep. Adrian Jay C. Advincula, there being no objection, the Body referred the privilege speech of Representative Cojuangco to the Committee on Rules for its appropriate action.

Thereafter, on another motion of Representative Advincula, the Chair recognized Rep. Rosanna "Ria" V. Vergara for her privilege speech.

PRIVILEGE SPEECH OF REPRESENTATIVE VERGARA

Representative Vergara spoke about the unprecedented crisis in the healthcare sector due to the migration of healthcare workers (HCWs) in search of higher-paying jobs and better working conditions in First World countries that contribute to the dwindling number of experienced HCWs across the nation. She stated that the World Health Organization adopted a Global Code of Practice on the International Recruitment of Health Personnel in response to the mass exodus of HCWs that appeals to wealthy nations to recruit through bilateral agreements and to work with the health ministry in the countries of origin but has remained unimplemented.

Representative Vergara urged the government to implement policies, programs, and regulations to address HCW migration, invest in education and training programs for HCWs to ensure a steady supply of skilled professionals, and offer competitive wages and better working conditions to retain them. Lastly, she added that the government should find ways to alleviate and address the effects of the aggressive recruitment strategies by foreign countries, create a comprehensive database of HCWs for workforce needs, and develop policies that would benefit the healthcare sector.

REFERRAL OF PRIVILEGE SPEECH OF REPRESENTATIVE VERGARA

On motion of Representative Suansing (M.A.), there being no objection, the Body approved to refer the privilege speech of Representative Vergara to the Committee on Rules for its appropriate action.

TERMINATION OF PRIVILEGE HOUR

At this juncture, on motion of Representative Suansing (M.A.), there being no objection, the Body terminated the Privilege Hour

APPROVAL ON THIRD READING OF HOUSE BILLS

On successive motions of Representatives Suansing (M.A.), Advincula, Arbison, and Cojuangco (J.), there being no objection, the Body proceeded to the approval on Third Reading of the following House Bills, printed copies of which were distributed to the Members on May 3, 2023, pursuant to Section 58, Rule X of the Provisional Rules of the House:

With 260 affirmative votes, zero negative votes, and zero abstentions, the Body approved on Third Reading House Bill No. 7620.

CORRECTION OF VOTING RESULT ON HOUSE BILL NO. 7751

At this point, the Chair, as informed by the Secretariat, corrected the result of the nominal voting on House Bill No. 7751 which the Body had earlier approved on Third Reading, as follows: should be <u>257</u> affirmative votes instead of "256," and negative votes and abstentions remained at zero.
